



MONEY RETURN POLICY

- Team registration payment is not reimbursable.
- Initial Deposit and/or Payment made towards the hotel package reservation (US\$100 per person) is reimbursed to international teams that the visa request was denied by the American Embassy for their select country.
The following requirements must be met in order to seek reimbursement:
 - Provide copy of DS160 form granted by the embassy, for the visa appointment.

Note: Electronically submitting your DS-160 online application is the FIRST STEP in the visa application process. The next step is to review the internet page of the embassy or consulate where you plan to apply for your visa. Most visa applicants will need to schedule a visa interview, though some applicants may qualify for visa renewal. The embassy or consulate information may include specific local instructions about scheduling interviews, submitting your visa application, and other frequently asked questions.

YOU MUST BRING the confirmation page and the following document(s) with you at all steps during the application process:
Passport; Evidence of approved I-129F

You may also provide any additional documents you feel will support your case.

- This must be done prior to the tournament start date.
- Refunds will be made one week after the tournament event is completed.

The first deposit for registered participants who have a visa is refundable only in case of illness or death of the participant.

People who were included in the invitation letter as tournament participants and withdrew from the process for a reason other than those mentioned above, do not have a refund (whether they have a visa or not).

- Money received for hotel package reservation (2nd and 3rd payment) is reimbursable* only due to death or illness that prohibits travel/attendance by the participant or immediate family member, for which you must provide supporting legal documents.
- People who withdraw from the process for a reason other than those mentioned above do not have a refund (whether they have a visa or not).

*The amount reimbursed is based on the cancelation date, determined as follows:

- 60 - 31 days prior to the tournament start date = 50% of payment made

- 30 - 16 days prior to the tournament start date = 10% of payment made

- 15 days prior to the tournament date = non-reimbursable

Refunds will be made one week after the tournament event is completed.
